NOW THIS DEED OF TRUST DECLARES AND WITNESSETH AS FOLLOWS:

1. The name of the Trust shall be VALLURUPALLI RATTAYYA AND SEETAMMA CHARITABLE TRUST and the Trustees shall be collectively called 'Board of Trustees'.
